WASHINGTON - The Supreme Court on Tuesday threw out the convictions of wealthy financier Jeffrey Epstein, ruling that the jailed suspect should have been given a do-over as part of his plea deal over the charges. The justices agreed unanimously that the deal prosecutors struck with Epstein was unjust. But the high court, without explanation, limited its ruling to the issue of the procedural reason the conviction should be set aside. "Nothing in the Court's opinion should be read to cast doubt on the lawfulness of a plea deal that did not reach a plea agreement with respect to some or all of the counts in the indictment," the ruling said. "The question whether a particular plea deal is unfair is not before the Court." Get Breaking News Delivered to Your Inbox The decision to set aside Epstein's guilty plea came more than a decade after he was convicted of a single count of sex-trafficking involving a minor, and sentenced in 2008 to 18 months in prison with 12 hours a day of work and a day-for-day credit. Under terms of the deal, prosecutors agreed not to pursue other possible victims. But in a highly unusual move, the Justice Department later said it had recently discovered more victims. Prosecutors said they could not pursue those new crimes because the deal was not specific enough. They said that meant Epstein could be prosecuted for those charges. Attorney General William Barr said the government was not bound by the old deal to drop the additional charges. "Prosecutors are absolutely free to re-file charges if new evidence warrants," Barr said. The high court did not give any indication that it believes the underlying conduct was legitimate. But the justices ruled in favor of prosecutors, saying the single charge was not the full extent of the alleged crimes. The lengthy ruling, written by Justice Ruth Bader Ginsburg, came with some surprise language. She said that "new evidence may not even warrant a retrial" -- an apparent allusion to the high court not setting a precedent that would allow prosecutors to re-try anyone with new charges. The court in a series of opinions last year ruled that it was not for the justices to set a 3e33713323
